

THIS LICENCE is dated the <<Date>> <<Year>> and is made **BETWEEN:**

1. Definitions and Interpretation

In this licence, except where the context requires, the following terms shall have the following meanings:

'Fishing Rights'

means the right to fish in the River using rod and line only [but not to carry any fish away] **OR** [and to take and keep any fish taken]

'Licence Fee'

means the sum of money payable per year exclusive of value added tax;

'Licence Period'

means the period from <<Insert Date>> to <<Insert Date>> (inclusive)

'Licensor's Premises'

means the premises at <<Address>>;

'Parking Area'

means the area of land at the Licensor's Premises [shown edged on the plan attached to this licence];

'Permitted Days'

means the <<Insert Number>> Days of Use e.g. Mondays, Wednesdays, <<Insert Days>>;

'Permitted Hours'

means the <<Insert Hours>> hours of use e.g. 9am to 5pm>> on the <<Insert Days>>

'River'

2. Grant of Fishing Licence

2.1 The Licensor permits <<Insert Number>> members for the time being (including all those authorised by the Club) to exercise the Fishing Rights on the Permitted Days and during the Permitted Hours for the Licence Period

2.2 The Licensor also grants to the Licensee to be exercised in connection with the Fishing Rights:

- 2.2.1 the right to enter the Licensors's Premises with or without vehicles over the Riverbank in order to gain access to any Fishing Area;
- 2.2.2 the right to park on the Fishing Area.
- 2.3 The Fishing Rights are to be exercised in common with the other members of the Club [provided that the Licensee shall not grant any other person a licence in respect of the Fishing Rights].
- 2.4 [The Licensors grant the Licensee the right to construct and maintain the following facilities, and the Licensee must remove the same before the end of the Licence term as requested by the Licensors: <<Insert description of facilities and specifications>>.]
- 2.5 This licence is personal and may not be transferred, except to the trustee of the Club.
- 2.6 The Licensors may terminate the Licence at any time with immediate effect by giving the Licensee notice if the Licensee is in breach of any of its obligations in clause 2.2.

3. Licensee's Covenants

- 3.1 The covenants in this clause shall bind the Licensee on behalf of themselves and the members of the Club and all those authorised by the Club to exercise the Fishing Rights.
- 3.2 The Licensee shall pay the appropriate value added tax in respect of it.
- 3.3 The Licensee shall provide the Club with a membership card which must be produced on request when the member is on the Licensors's Premises.
- 3.4 The Licensee shall exercise the Fishing Rights in accordance with the following conditions:
- 3.4.1 in a fair and reasonable manner and only during proper seasons;
- 3.4.2 in accordance with the laws in force from time to time;
- 3.4.3 only on the Riverbank during the Permitted Hours.
- 3.5 The Licensee shall ensure that the following conditions are to be done any of the following:
- 3.5.1 allow any other person to exercise the Fishing Rights other than a member of the Club and any person authorised by the Club;
- 3.5.2 exercise the Fishing Rights granted in clause 2.2 in a way that interferes with the enjoyment of the Licensors or any persons authorised by the Licensors;
- 3.5.3 cause any damage to the Licensors, its tenants, or the premises of any neighbouring premises;
- 3.5.4 [remove from the River any fish measuring less than <<Insert measurement>>] and if any fish is caught to return it to the River;
